Being a volunteer is a fantastic opportunity for members to play a role in helping to decide the short- and long-term directions for the Credit Union and its membership.

To be a volunteer, you must:

- be a member of PFCU in good standing.
- be at least 18 years old.
- be bondable by the Credit Union's fidelity bond company.
- authorize a criminal background check as well as a credit check.
- attend a minimum of one (1) meeting per month time varies based on volunteer role.
- actively participate in self-study training programs as needed based on volunteer role.

If you are interested in being nominated for the role of a Board of Director, please perform the following:

- Submit a petition signed by 162 PFCU members (1% of the PFCU membership).
- 2 Complete the attached *Prospective Volunteer Questionnaire*.

If you are selected as a nominee for a 3-year term on PFCU's Board of Directors, then the anticipated timeline for elections are as follows:

12/2022	The slate of nominees is determined and approved by the Nominating Committee. Nominees' bios must be submitted by December 2,2022.
01/03/2023	List of nominees' names along with Annual Meeting information are mailed in the quarterly statements or separate direct mailer. This notice also includes information that nominees can be added to the list of candidates with a petition signed by 1% of membership.
02/15/2023	Petition deadline.
03/15/2023	Members receive notification to vote, if applicable.
04/21/2023	Voting ends.
04/26/2023	Election results announced at the Credit Union's 60 th Annual Meeting, Wednesday, April 26 th .
04/26/2023	Newly elected board members will be seated with the full Board for their first Board meeting immediately after the Annual Meeting in-person. Election of table officers (Board Chair, Vice Chair, and Secretary) will be the first order of business. Board meetings are typically from 3pm – 5pm on the third Wednesday of every month.

- 3. Once the petition has been completed with the required number of signatures, it must be returned along with the completed *Prospective Volunteer Questionnaire* via email, branch, or mail (see cover letter for contact information).
- 4. Membership and signatures of signers will be verified.
